If receiving a make up application, be sure your skin is clean and moisturized before arriving. Make-up applications include false lashes, if desired.

I understand that the full price of the package will not be refunded upon cancellation unless more than seven (7) days' notice is given by me. I understand that no refund will be given for members of the wedding party who miss their appointment or choose to cancel without 14 days notice before day of the event.

Covid-19 updated policy- We will refund your entire deposit if the wedding is cancelled due to the pandemic, regardless of timing.

*All bookings carry a minimum amount of 3 hair and/or 3 make up services, excluding gratuity and travel fee. We will consider exceptions to the minimum based on availability of stylists.

Policies

Securing Appointment Date:

Your appointment date(s) and service(s) will be secured when the signed contract and 50% deposit have been received. All booking for weddings are made on a “first-come-first-served” basis. No dates will be guaranteed without a signed contract, service and pricing sheet and deposit.

Cancellations:

Cancellations require a two month (60 days) notice prior to the service date. Cancellations not made with at least a 60 day notice will forfeit the 50% deposit to secure the service date. A 1-7 day notice of cancellation will be charged 100% of the total with the credit card on file. Cancellations due to emergencies are considered on a case by case basis at the discretion of Daymaker Brides.

Contract and Appointment Changes:

All agreements will be made in writing. Wedding date and time, service date, time of arrival, estimated time of completion, name(s) of guest(s) to be styled and service descriptions will be mailed or sent via email. Any changes/additions to guests or wedding party members requesting additional services after the contract is signed must be submitted in writing (no changes will be made over the phone). The bride/individual signing this contract is the only person permitted to authorize, submit and change any arrangements for the wedding party. Please send any changes or requests via email (info@daymakerbrides.com).

Service add-ons will gladly be accepted on the day of the wedding if time permits. Daymaker Brides requires sign off and cash, venmo or check for these services.

Late Arrivals:

Tardiness results in scheduling and service conflicts for you and other clients following your appointment(s). If the scope of the original contract cannot be fulfilled due to client’s tardiness, services may be reduced; however, clients are liable for the original amount.

If a wedding party is more than forty five (45) minutes late without making contact with us, the assumption is the client is a no-show. This will result in the client forfeiting all deposits and your credit card will be charged 100% of the total services.

We leave you and ourselves plenty of time for each service when we create your day of itinerary.

No one wants to feel rushed, especially on such an important day. We often run ahead of time, which allows for last minute touch-ups and add-on services. For these reasons, please arrive 15 minutes early for your scheduled appointment(s).

Payment

Deposit:

A 50% deposit is required to secure the wedding date. The reservation(s) will be canceled if payment and the signed contract are not received in a timely manner. This deposit is used to reserve stylists on the date requested for your wedding and will be deducted from your package total as payment for the bridal package. Check by mail is preferred.

Trial Run:

A trial run is suggested but not required. The trial run fees will be included in the total cost of the wedding. Cancellations made with more than two months (60 days) notice prior to the service date but after the trial run will be reimbursed the 50% deposit less the cost of the trial run plus 20% gratuity.

Payment in Full:

Remaining balance is due at least 7 days prior to the wedding date. We accept checks payable to Daymaker Brides and mailed to:

We also accept cash, and credit cards as methods of payment. Please note that an additional 3.5% will be added to your invoice for all credit card transactions. A 10% discount will be given for cash.

Gratuity:

20% gratuity will be added to the final total of all bridal packages.

Travel Fee:

A travel fee of \$80 will be added to all bridal packages in the Truckee/North Lake area. Additional charges will be applied if location of wedding is 30+ miles away from Truckee, CA. Graeagle, Reno and South Lake travel fee is \$200.

Additional Information:

Our experienced and professional stylists of Daymaker Brides are ready to accommodate all skin tones, ethnic features, hair textures and lengths. However, it is always helpful and appreciated to know in advance of any service that will be performed on lighter or darker skin tones or ultra long and/or thick hair. Also, we require prior notice if hair extensions will be added by our hair stylists.
